Ubisoft+ Free Termed Access (non-renewing) We are excited for you to explore our worlds! This free termed access to Ubisoft+ **will not auto-renew** after it expires. **After your termed access expires:**

1. if you want to continue to have access, you will need to subscribe to Ubisoft+ via <https://store.ubi.com/ubisoftplus> and enter a credit card. Your subscription will auto-renew each month at the then-current monthly rate.
2. if you do not subscribe to Ubisoft+ within thirty (30) days of the expiration, you will lose your Reward status, but any Rewards earned during your active access will remain available to you should you play games with such Rewards.
3. the games will become unavailable, but your saved progression will be kept for games that support cloud saves or if you keep your local saved files.
4. all consumables you bought in-game will be available if you buy the game on the Ubisoft Store or if you subscribe to Ubisoft+ again in the future.
5. downloadable content packs (DLCs) and expansions you get access to as part of your Ubisoft+ subscription will be available if you buy the Gold Edition or the Season Pass of the game on the Ubisoft Store, or if you subscribe to Ubisoft+ again in the future.
